Supplementary Material for Economic Development Authority Board Application

I was appointed to the EDA in March 2015 to complete the unexpired term of the member representing the Samuel Miller District who had resigned. I have served in that role since March and have acquired a good working knowledge of the EDA and its role, and feel that I've been able to make a contribution to the EDA. In particular, I think my experience as an entrepreneur and businessman add an important dimension and viewpoint to the Board.

Prior to my appointment, I had worked with Susan Stimart and Lee Catlin on work groups related to economic and workforce development and to establishing an Economic Development function for Albemarle County. Based on that experience, Susan encouraged me to consider applying for the position on the Economic Development Authority Board when it became vacant.

My business experience in Albemarle County began in 2001, when Mike Appleby and I co-founded Mikro Systems Inc, a small technology and manufacturing company. We started with 3 people in a 2500 square foot facility, and currently employ 70 people in a 25,000 square foot facility located in the Old Comdial Building. Under a licensing agreement that Mikro made with Siemens Energy, two years ago, Siemens recently opened a 45,000 square foot facility located in University Research Park, to manufacture products using Mikro's technology. This Siemens facility currently has about 50 employees and is growing.

I'm familiar with the needs of a start-up company as well as how those needs change as the company grows, and also am aware of some of the difficulties and limitations in terms of available infrastructure and resources in our community. My involvement with Susan and Lee has included participating on work groups related to economic and workforce development and has provided some insights into local needs. At ISU, I was chair of the Departments of Landscape Architecture (1994-2007) and Community and Regional Planning (2002–2007), co-instructed the Savanna Traveling Studio, taught theory seminars, and co-instructed community design and advocacy studios. In addition, I was principal investigator for more than \$2 million and co-principal investigator for more than \$15 million in externally funded projects. Among other projects, I directed a multi-year effort for the Iowa DOT focusing on the Lincoln Highway/US 30 and Interstate 80 that has informed my understanding of transportation planning. I also helped oversee Iowa's Living Roadways Community Visioning project, an award-winning (FHWA Award for Environmental Excellence, 2004 and APA Outstanding Planning Award, 2006), multi-year, community-directed design for more than 200 rural Iowa communities.

I grew up in Central Virginia, having moved with my family from California to a Fluvanna farm when I was three. My mother was a social worker in rural Virginia in the 1950s, and I grew up with an acute awareness of rural issues, many of which still persist today. I attended a 4-room school before we moved to Albemarle where I attended McIntire School until our home was annexed into the City of Charlottesville. An Albemarle County property owner since 1991, I enjoy living in a rural area again, but I also benefit from the county's modern medical facilities, revitalized villages, upgraded rural roads and convenient access and proximity to a broad range of goods and services.

I bring the perspective of growing up in Albemarle and adjacent jurisdictions, but also of living and working in other regions of the country. I have completed a significant body of work in our National Parks and have earned three Honor and four Merit Awards from the American Society of Landscape Architects as well as the prestigious Public Service Award from the Secretary of the Interior. I am a contributing author to two award-winning books- A Richer Heritage and Saving America's Countryside—and have authored/co-authored other publications on rural, landscape, and planning topics. The iconic images of Albemarle County inspire me and have provided a valuable background for my own writing and research. The outreach studios that I have conducted as a professor have addressed rural and urbanizing communities dealing with environmental disasters, population changes, cultural and eco tourism, and a variety of associated economic and environmental issues. Notably, these include planning visual enhancements and transportation improvements for the Amana Colonies—a 26,000-acre National Historic Landmark; working with the Des Moines Area Food Pantry System on Relieving Food Uncertainty to define and map hunger patterns, redesign the pantry system, investigate ways to integrate fresh foods for pantry

users and support local agriculture; advising the Iowa Wildlife Center on its 75-acre hospital/education center for wildlife rescue, rehabilitation, and release; and perhaps most gratifying, working with Mapleton, Iowa in an ASLA award-winning project in long-term disaster recovery from an EF3 tornado that destroyed many residences and businesses and damaged a school.

I am fortunate to live in Albemarle County where both the residents and the land continue to inform my understanding of landscape continuity and change. That privilege comes with a responsibility to pay back with public service, and I would be honored to continue to serve as the at-large planning commissioner.

Dear Mr. Foley:

In 2002, the Thomas Jefferson Soil & Water Conservation District (TJSWCD) created the Thomas Jefferson Water Resources Protection Foundation (Foundation), a nonprofit subsidiary of the TJSWCD that administers the District's easement program. The Foundation's Board of Directors includes two volunteer citizen appointees from each of our member localities. One of those citizens is appointed by the local governing body, and the other by the TJSWCD Board of Directors.

Steve Murray was appointed by the Albemarle County Board of Supervisors in 2009 and his current term will expire in January 2016. He wishes to continue serving on the Foundation Board. The Foundation is recommending that the Albemarle County Board of Supervisors reappoint Mr. Steve Murray as a representative to the Foundation's Board. Mr. Murray's resume is included with this letter of recommendation.

The TJSWCD's easement program is aimed at securing and maintaining permanent easements on lands that are critical to the protection of water resources, with a primary focus on riparian lands. The parcels upon which the District holds easements are generally small in acreage. These easements can overlay larger easements held by the County or by entities such as the Virginia Outdoors Foundation.

The reasons for setting up a Foundation to administer our easement program are twofold. First, the Foundation is a sustainable funding source, separate from the District's operational budget (which is subject to the variations of State & local budgets), dedicated to paying the long-term costs of performing custodial duties to ensure easement compliance. Second, the Foundation is a means of ensuring that the interests of our member localities are adequately represented.

The TJSWCD will continue to be the holder of any easements secured under the program. However, the Foundation has the responsibility of working closely with local governments and landowners to craft easement terms that satisfy the interests of all parties. Any easement that the District takes on must be consistent with the Comprehensive Plan of the locality in which it resides. Therefore, good communication among the District, Foundation, and local governments is important.
