Diane Brown Townes is the owner of BTE Productions. She writes and develops American History/community engagement programs. BTE Productions initially aired a series called Mid-Atlantic Perspectives on the Charlottesville/Albemarle community's local cable access television.

Graduated from Virginia Union University and majored in Humanitarian Studies.

Earned a BA in Sociology with experience in research, objective assessment, evaluation and setting project planning goals.

Earned a Governor's Fellowship to study at the University of Virginia.

Graduated from the University with a Master of Education degree in Social Studies/History.

After raising 3 children, Diane became a health care provider and advocate for her family. She also shared provider service resource information with our community members. For example, she would assist with the facilitation of care plan activities/activities of daily living.

Diane also served in the role of geriatric care provider, medical coordinator, advisor, and health education navigator advocate while facilitating the recovery of traumatic brain injury patients at a facility in the Middle East.

Ms. Brown Townes believes that the core premise for developing community engagement programs offers the community a chance to connect with storytelling. "When people know who they are and they are able to connect to personal stories those stories foster some manner of reconciliation and healing. I've learned that no matter where we are global, communities around the world share similar experiences."

Please find below a brief description of some of the projects produced by BTE Productions:

Lane High School; a Legacy of Racial Tensions

The Lane High School story featured graduates from the class of 1973. History of Lane High School was shared with the community. Graduates described what it was like before Charlottesville Public School administrators and City Council voted to have a new high school erected.

Today, Charlottesville High School's diverse staff is reflective of the hard work and efforts of the first African American Assistant Principal to have ever been hired at the secondary school level in 1973.

An example of another program produced by BTE Productions, helped the community to understand what it was like visiting Monticello before the development of Archaeological projects that took place throughout the 1970s, '80s, '90s and the 21st. Century.

Monticello the Plantation Story's focus was about the Digital Archaeological Archive of Comparative Slavery and what it was like for Archaeologist to examine the life of enslaved Africans and their descendants from the Chesapeake, Carolinas, and Caribbean during the colonial and Ante-Bellum Periods. DAACS is a community resource, conceived and maintained in the Department of Archaeology at Monticello in Charlottesville/Albemarle County.

BTE Productions plans to produce and organize community forums inviting musicians/artist, literary authors, historians, and community activist and unsung heroes annually/biannually

Brown Townes Education Productions partnered with the Albemarle County Public Schools to engage students in classroom discussions about the first African American Marines.

University of North Carolina Wilmington Professor Emeritus Melton McLaurin was invited as a guest speaker to lead the discussion on his book; The Marines of Montford Point North Carolina.

I recently served on the George Wright Society's conference panel to discuss my role as Community Ambassador for the Memorial to Enslaved Laborers community engagement project.

The discussion revolved around protecting our national parks and public spaces: *Truth, Reconciliation, and Healing Protecting Public Spaces & Providing Contextual Meaning to Our Nation's Historical Landmarks.*
