### **Construction Activities**

#### **Road Project**

• Afton Mountain – Warning system installation in progress. Estimated completion date January 9, 2025.

#### **Bridge Project**

- Route 708 Red Hill Road Bridge Replacement Work began November 6th. Beginning Thursday, August 1, traffic shifted to the newly completed portion of the bridge. A temporary signal will continue to control the intersection of Red Hill Road and Route 20 (Scottsville Road). After the traffic shift, work began on the second half of the bridge. Expected completion is December 5, 2024.
- Route 641 Frays Mill Road Bridge Replacement over Marsh Run Complete 3 months ahead of schedule.
