**BACKGROUND:**

A public hearing was held at the Planning Commission (PC) on September 9, 2025 for ZMA202200002. Based on concerns from the PC, the applicant requested deferral of the public hearing to December 16, 2025. The applicant submitted revised application materials to address concerns expressed by the PC at the September public hearing. A summary of the changes are included in Attachment A1.

**DISCUSSION:**

The revised application materials were discussed at the PC's December 16, 2025 meeting. The PC voted 5:2 (Missel, Firehock opposed) to recommend approval of ZMA202200002 for the reasons listed in the staff report. The PC staff report, action memo, and minutes are attached (Attachments A, B, and C). No changes have been made since the PC public hearing in December.

**RECOMMENDATIONS:**

Staff recommends that the Board adopt the attached Ordinance to approve ZMA202200002 Sieg Property Rezoning (Attachment D).
