Construction Activities

Bridge Projects

- Rte. 601 Old Ivy Road over Rte. 29 Superstructure Replacement Construction began February 17th.
 During construction, the bridge is restricted to eastbound traffic only, with a reduced lane width. Detour signage is in place. The anticipated completion date for this project is Summer 2026.
- Rte. 712 Plank Road Reconstruction of headwall. Traffic will be reduced to one lane maintained by a temporary traffic signal. Construction began July 7th and is expected to be completed by August 8th.
