I am writing regarding the project at 1805 Avon St Ext. I do not object to the project as a whole. I feel it can provide some needed housing in a popular area of Albemarle County. I do have two concerns to express:

1. There is currently an easement from the private roads of Avinity to the back of this property. Since the development will be connected directly to Avon St, this easement/connection should be closed. Either permanently or blocked only allowing access for emergency vehicles. The Avinity roads are not set up for additional traffic, the roads are private with no interest in additional wear & tear on the roads, and a connection would cause confusion on if the Avinity amenities are available to the residents of the new development.

2. The overpopulation at Mountain View is extreme and doesn't appear to be getting resolved until a proposed new school is built. Although I support the project as a whole, the timing is not appropriate until the overpopulation resolution would be completed prior to new residents moving in.
