### Bridge Projects

- **Route 640 Gilbert's Station Road – Bridge Repair** – State forces anticipated to begin work Summer 2020. May be delayed due to delay in getting RR clearance.
- **Rte. 606 Dickerson Road – Truss Replacement** – State Forces work has begun. Road will be closed until approximately late November 2019.
- **I64 E&WBL over Rte. 20 & I64 EBL over Rte. 29 – Latex Overlay** – Contractor began lane closures on August 16, 2019 and multiple weekends afterwards.
