Construction Activities

Road Project

• Route 240/250 – Crozet Avenue/Rockfish Gap Turnpike – Turn lane extension. Start date August 12th. Expected completion before August 21st.

Bridge Project

- Route 708 Red Hill Road Bridge Replacement Work began November 6th. Three traffic signals have been installed making it a signalized intersection, temporary pavement markings, and temporary barrier wall. The temporary signals were activated the morning of Tuesday 12/5/23. The first half of the bridge is nearly complete. Beginning Thursday, August 1, traffic will shift to the newly completed portion of the bridge. A temporary signal will continue to control the intersection of Red Hill Road and Route 20 (Scottsville Road). After the traffic shift, work will begin on the second half of the bridge. Expected completion is December 5, 2024.
- Route 641 Frays Mill Road Bridge Replacement over Marsh Run Road will be closed at Route 743 (Advance Mills Road) for replacement of bridge over Marsh Run on January 2nd. Expected completion date, December 5, 2024.
- Route 810 Boonesville Road Replacing Superstructures and reconstructing the top of the abutments Construction started June 24th. A message board was activated at the bridge on June 10th providing notice of the closing date and projected opening date. Roadway will be closed to all vehicular, cyclist and pedestrian traffic. There will be a detour to guide traffic around this closing. Estimated completion date is August 20, 2024.
