Green highlighted Roads have enough signatures to be paved and are being included on the current SSYP

With the new BOS rule as of 2022, roads that had been previously approved will need to satisfy the requirements of 2/3 of the residents on the road approving the project.

BOS says to prioritize roads based on traffic volumes, highest being first, and if there is a tie, to use highest number of crashes as tiebreaker

NOTES: all updated traffic counts as of 12.11.2023  
VDOT makes the determination on whether a road is eligible for RRR paving. All projects are placed on the regular paving list until the determination is made by VDOT. [Some projects may not be completed as prioritized due to project complexity and/or available funding]. The BOS prioritizes roads to be paved based on the most traffic counts. If there is a tie, then it goes to which road has had more crashes
