Justification for request:

We are requesting sanitary sewer service for the new laundry & maintenance building location and lightning shelter as shown on the plans entitled Farmington Country Club - Tennis & Fitness Building. The proposed locations for the facilities is in the water only service area for ACSA. The existing laundry & maintenance building is currently served by both public water and sewer. Sewer service is provided via a connection to a private sanitary sewer located on Farmington property that drains to a sanitary pump station. The sanitary sewer is discharged from the pump station to a force main. The force main discharges to the public sewer system at the intersection of Old Garth Rd. and Rt. 250.

We are proposing to connect to the on-site private sanitary sewer upstream of the connection point with the publicly maintained sanitary sewer. As stated the existing laundry and maintenance building is currently served by this system. No increase in flows are anticipated with the relocated facility. In addition, the adjacent indoor tennis facility and ground maintenance buildings are served by the on-site private sanitary system. Both facilities are located within the water only ACSA jurisdictional area.

These facilities are located within the drinking water watershed for Ivy Creek. The construction of a septic tank and associated drain field has the potential for ground and surface water contamination within the drinking water watershed in the event of failure or improper construction. Surface waters can be contaminated with pathogens, such as E. coli, chemicals, and nutrients including nitrogen and phosphorus. Freshwater rivers, lakes, and ponds are particularly sensitive to phosphorus contamination from failing or improperly constructed septic systems. Connecting to the on-site sanitary sewer will allow for the sanitary effluent to be treated at the sewage treatment facility and help to prevent any potential impacts to the drinking water watershed.
