Before retiring, he taught science and technology policy and directed the Policy Internship program at the University of Virginia's engineering school. His particular interest is in the application of science to public policy. In 2016, he served on a panel of the National Academies of Science, Engineering and Medicine reviewing science and policy on genetically engineered crops. From 2000-2008, Mr. Rodemeyer directed the Pew Initiative on Food and Biotechnology, a nonprofit project on agricultural biotechnology issues funded by the Pew Charitable Trusts. Prior to that, Mr. Rodemeyer served as the Assistant Director for Environment in the Office of Science and Technology Policy in the Clinton White House and as Chief Democratic Counsel for the U.S. Congress Committee on Science and Technology.
