## Construction Activities

### Bridge Projects

- **Rte. 693 Stillhouse Creek Emergency Bridge Replacement** – Completed April 14<sup>th</sup>.
- **Rte. 601 Old Ivy Road over Rte. 29 Superstructure Replacement** – Construction began February 17<sup>th</sup>. During construction, the bridge is restricted to eastbound traffic only, with a reduced lane width. Detour signage is in place. The anticipated completion date for this project is Summer 2026.
- **Rte. 712 Plank Road** – Reconstruction of headwall. Traffic will be reduced to one lane maintained by a temporary traffic signal. Construction to begin April 2025
