Bridge Projects

- Route 708 Red Hill Road Bridge Replacement Construction started November 6th. Beginning Thursday August 1, traffic shifted to the newly completed portion of the bridge. A temporary traffic signal will continue to control the intersection of Red Hill Road and Route 20 (Scottsville Road). After the traffic shift, work began on the second half of bridge. Expected completion December 5, 2024.
- Route 641 Frays Mill Road Bridge Replacement over Marsh Run Complete 3 months ahead of schedule.
