PETITION FOR THROUGH TRUCK RESTRICTION ON EARLYSVILLE ROAD (Route 743)

We, the undersigned, who live on Earlysville Road (Rte 743) between Rio Road W. (Rte 631) and Dickerson Road (Rte 606), do hereby request the Albemarle County Board of Supervisors and the Virginia Department of Transportation restrict any truck or truck and trailer or semitrailer combination, except a pickup or panel truck, that has no point of origin or destination along the subject route. This request applies only to through-bound trucks and it is made for the following reasons:

1. The rural nature of Earlysville Road (Rte 743) is characterized by narrow pavement widths, inadequate or no road shoulders, steep banks to the Reservoir, and curves and hills that limit sight distance.
2. The physical characteristics of Earlysville Road create an incompatible and unsafe environment between truck or truck and trailer or semitrailer combination and the other vehicles using the roadway. Truck and other vehicle travel speeds compound the issues caused by the physical characteristics. The sharp curves require a semi trailer front and/or rear axles to cross the center line.
3. Over many years citizens have expressed concern for safety getting their mail, as well as for fully loaded school buses, en route to Albemarle High School and Broadus Wood Elementary, and for personal vehicles encountering single or tandem trucks traveling in the opposite direction with inadequate road width to navigate.
