I am a certified planning commissioner, and add also my distinct skill set as a professional landscape architect registered in the Commonwealth of Virginia as well as experiences from a distinguished career as professor of landscape architecture.

As an Albemarle County property owner since 1991, I value living in the rural area, but also realize the benefits of modern medical facilities, revitalizing villages, upgraded rural roads, and convenient access and proximity to a broad range of goods and services. I grew up in Central Virginia with a social worker mother who fostered my acute awareness of rural issues and the interrelationships among the social, economic, and physical conditions still found in the rural environment today.
