Bridge Projects

- Rte. 693 Stillhouse Creek Emergency Bridge Replacement Inclement weather delayed work and anticipated re-opening at the end of January. Expected completion date is now the middle of April barring additional weather.
- Rte. 601 Old Ivy Road over Rte. 29 Superstructure Replacement Construction will begin February 17th.
