## Albemarle County Comprehensive Plan Update

## Working Group Member Application, Selection, and Outreach Process

Albemarle County is seeking community members with a diversity of perspectives and experiences to participate in the Comprehensive Plan Update Working Group. Working Group members will advise County staff on Comprehensive Plan recommendations and community engagement approaches, as well as support community outreach efforts by sharing information within their networks, neighborhoods, and/or communities.

Working Group members will:

- Review and provide feedback on the Comprehensive Plan Community Engagement Plan and related outreach materials;
- Advise staff on plans for public input opportunities (community workshops, pop-ups, focus groups, etc.);
- Actively encourage participation, build relationships, and engage community members outside of regularly planned meetings and events (social media posts and sharing of County posts to interest groups);
- Participate in, observe, and attend public meetings;
- Review written summaries of public input, policy and planning options, and draft plan content;
- Advise staff on Comprehensive Plan recommendations, based on research, summaries of public input, and planning best practices; and
- Attend monthly Working Group meetings, learn about planning and development concepts, and review advance materials, as needed.

The anticipated time commitment for this role is 10 hours per month. Staff recommends payment be provided at a rate of \$15/hour to compensate participants for their time and expertise shared with County staff.

No prior volunteer, education or work experience in community planning or development is required. Monthly working group meetings will include staff-led trainings on fundamentals of urban planning and community development.

We encourage applicants from communities in Albemarle County that have traditionally been underrepresented in our planning processes. These include (but are not limited to) those who are:

- Below the age of 35
- Over the age of 65
- Are renters
- Have attained no more than an Associate's degree / some college credit
- Part of low-to-moderate income households
- Speak multiple languages at home
- African American, Black, Hispanic or Latino
- Foreign-born or non-US citizens
- Work in Albemarle County, and wish to reside in Albemarle County

## Working Group - Representation Goals

County staff are seeking to integrate Albemarle County's new organizational value of Community (*We expect diversity, equity, and inclusion to be integrated into how we live our mission.*) into the Working Group application and selection process using the Albemarle County Equity Profile's findings as a guide.

County staff aim for a Working Group comprised of community members with a diversity of perspectives and experiences in Albemarle County, including those who haven't historically been engaged on the Comprehensive Plan, such as those who are:

- Below the age of 35;
- Over the age of 65;
- Are renters;
- Have attained no more than an Associate's degree / some college credit
- Live in Census Tracts with a lower American Human Development Index (AHDI) score than Albemarle County's overall score of 7.42;
- Part of ALICE (Asset Limited, Income Constrained, Employed) households;
- Speak multiple languages at home;
- African American, Black, Hispanic or Latino;
- Foreign-born or non-US citizens;
- Work in Albemarle County, and wish to reside in Albemarle County;

# **Communications and Outreach Approach**

- Direct outreach / invitations
  - Focus will be on outreach to community groups, neighborhoods and organizations that work with and/or made up of populations typically underrepresented in the County's planning processes (ex. Youth, people of color, low-to-moderate income households, rural area residents, community members who speak multiple languages/whose first language is not English);
  - Leverage contacts from various departments within the organization such as Office of Equity and Inclusion, Communications and Public Engagement, Department of Social Services
  - Outreach will include sending personalized emails, making phone calls, and forwarding communications and information about the Comp Plan project and working group.
  - Pop-ups at various locations with focus on areas with populations typically unrepresented, as listed above.
- Project Website
  - Create online website hub for information about the Comprehensive Plan update and opportunities for participation, including how to apply for the Working Group (will be consistently updated with engagement summaries, video/recordings of meetings, and draft interim work products).
- Social Media
  - Leverage existing County social media accounts to spread the word
- Media Coverage:
  - Outreach to local news outlets (TV, print, and online) to share information about Working Group opportunity.
