Attachment E Albemarle County Investment Report First Quarter Ended: September 30, 2023 (1st Quarter, FY 24)

Discussion

Albemarle County invests excess cash on behalf of its funds and those of its fiscal agencies. The 1st Quarter of FY 24 (not YTD), earnings were \$2,474,000, compared to \$696,000 in the 1st Quarter of FY 23. This increase is primarily due to the rising interest rates and timely investment of available funds. Year-over-year the average quarterly Federal Funds rate increased from 2.19% to 5.26%. Excess cash remains liquid in Bank of America and the LGIP, Local Government Investment Program, which is administered by the Commonwealth of Virginia.
