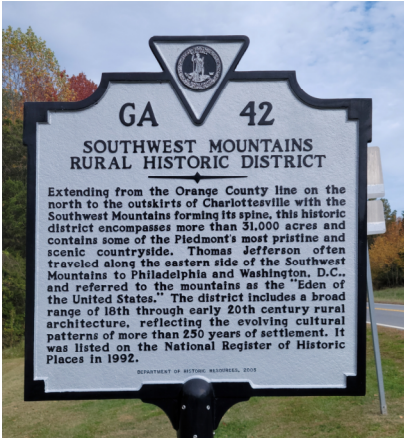

To Whom it May Concern,

We are writing to express **our opposition** to the special use permit application submitted by Service Dogs of Virginia (SDVA) to build a dog kennel, 20 space parking lot, residential dormitories, and a training facility on Turkey Sag Road in Keswick VA.

We are residents of Albemarle County and have owned and lived on a farm near the proposed site for the past 23 years. We have several concerns about the impact of this project on our (and our neighbor's) quality of life.

First, the kennel and dormitories would increase the noise and traffic in the area. Our family has built hiking trails throughout our 90 acres for the enjoyment of our large family. Over the years, our farm has also hosted wellness retreats and not for profit workshops for various groups, such as area educators. The barking of the dogs and the coming and going of the staff and volunteers would disturb the peace and quiet of these gatherings as well as our ability to enjoy our own property.

Secondly, the kennel compound would be incompatible with the rural character and aesthetic of the neighborhood, which is zoned for agricultural and residential use. The kennel and dormitories would be an eyesore and a nuisance and would lower the property values and the quality of life of the residents. The beautiful sounds of horses, cows and even an occasional donkey are all a part of rural life--kennels, dormitories and incessant barking dogs are not.

Thirdly, there is no need for a kennel and dormitories in this neighborhood. By definition, the need for a special use permit implies there is something special about this situation. This is simply a commercial operation. Its location is being proposed in this area because of the convenience to the Director, Peggy Law, and her specific knowledge of the property. Her personal residence is directly adjacent. We simply don't "buy" the argument presented at the last meeting that The SDVA looked everywhere, far and wide, and couldn't find anything else suitable. The zoning for this area is specific and should be honored.

At the previous meeting, The Applicant for the permit "implied/threatened" that the property was already zoned for development of 5 estate properties. The implication was clear. If a special use permit was denied, the property would be developed and there would be more disturbance, noise, light, traffic, etc. -- So be it we say! That was the risk that we took when we bought our property 23 years ago. That was the deal. The deal wasn't, that we should pour our money and sweat into creating a tranquil, beautiful, rural lifestyle only to have it shattered by an operation that should never be proposed or approved.

We respect the mission and work of SDVA, but we must separate the quality of organization's mission from the realities of the operation. We believe that their proposed project is not suitable for this location. We urge you to deny their special use permit application and to protect the interests, rights, and property values of the residents of Albemarle County.

Dear Mr. Shoaf:

We write to object to the Special Use proposals for construction of a canine breeding and training facility for Service Dogs of Virginia (SDVA). We are owners of the property adjacent to the proposed site and currently use the property for tree farming and recreation.

The proposed commercial operation would drastically upend the rural, pastoral nature of the Rosina area with construction of a complex of buildings with up to 50,000 square feet of heated space, including living quarters for students, caretaker, breeding kennels training facility and public meeting space. For perspective, the proposal envisions the same total square footage as the new Public Lands mega-store at Fifth Street Station. Rosina has one small country store and two churches. The area is not ready for such a massive complex with associated traffic, noise and environmental disruption.

While SDVA is a valued and worthy organization, the proposal to build the equivalent of a Target or small Walmart on the side of the Southwest Mountains in rural Rosina is wholly unacceptable.

We ask the Planning Commission to reject these proposals in their entirety.
