## RESOLUTION TO REQUEST THE COMMONWEALTH TRANSPORTATION BOARD TO RESTRICT THROUGH TRUCK TRAFFIC ON EARLYSVILLE ROAD

WHEREAS, Virginia Code § 46.2-809 provides that a locality may formally request that the Commonwealth Transportation Board or its designee restrict through trucks on certain segments of primary and secondary routes in the limited number of cases where doing so will promote the health, safety and welfare of the public without creating an undue hardship on any transportation users; and

**WHERAS,** many citizens who live along the portion of Earlysville Road (Rte.743) between Woodlands Road (Rte. 676) and Dickerson Road (Rte. 606) have signed a petition requesting a "Through Truck Restriction" along this section of Earlysville Road; and

WHEREAS, the procedures and requirements for initiating and implementing these measures are set forth in the policy adopted by the Commonwealth Transportation Board on October 16, 2003, "Guidelines for Considering Requests to Restrict Through Trucks on Primary and Secondary Highways"; and

**WHEREAS**, the proposed through truck restriction will include the portion of Earlysville Road (Rte. 743) beginning at the intersection of Woodlands Road (Rte. 676) heading north and terminating at the intersection of Dickerson Road (Rte. 606), a distance of 3.1 miles.

**WHEREAS**, Seminole Trail (US-29), Airport Road (Route 649), and Dickerson Road (Route 606), a distance of 7.6 miles, is a reasonable alternative to trucks now traveling along Earlysville Road between Woodlands Road and Dickerson Road; and

**WHEREAS**, this restriction would apply to any truck (every motor vehicle designed to transport property on its own structure independent of any other vehicle and having a registered gross weight in excess of 7,500 pounds) or truck and trailer or semi-trailer combination, except a pickup truck or panel truck.

**NOW, THEREFORE BE IT RESOLVED** that the Albemarle County Board of Supervisors, after holding a public hearing on March 9, 2016, hereby requests that the Commonwealth Transportation Board restrict through truck traffic on the portion of Earlysville Road between Woodlands Road and Dickerson Road.

**BE IT FURTHER RESOLVED** that the Albemarle County Board of Supervisors does support this request and states its intent that it will use its good offices for enforcement of the proposed restriction by the Albemarle County Police Department and any other appropriate law enforcement agency.
