Construction Activities

Route 29 Solutions

- All Route 29 Solutions projects remain on or ahead of schedule with the exception of the Route 29/250 Interchange project and the Hillsdale Extended advertisement date which was moved by the City of Charlottesville from December 2015 to March 31, 2016. The bids for the Hillsdale Extended project have been received and reviewed and the apparent low bidder has been announced (Fielder's Choice Enterprises). The fixed completion date for Hillsdale remains October 30, 2017. All design-build plan projects are currently on or ahead of schedule.
- The **Rio Road GSI** crossover was closed on May 23, 2016 and bridge construction work is underway. Mass excavation has been completed and current work includes storm drain installation, deck pours, and retaining wall construction. The new bridge and roadway will be opened to traffic on or before September 2, 2016.
- The **Route 29/250 Ramp** Improvement Project (Best Buy Ramp) was opened to traffic on May 20, 2016. There are minor elements remaining to be completed including small sections of barrier wall, minor grading, and light pole installations. Estimated completion of remaining items is July 2, 2016.
- The Project Delivery Advisory Panel held a project tour on June 9th and a meeting on June 23rd.
- The **adaptive signal** phase I work is complete. Additional side-road signal improvements not associated with adaptive phase I but associated with the Route 29 Solutions project have been completed. The installation and activation of the adaptive system will commence upon completion of the roadway and bridge projects

- Bridge Maintenance— In process of renewing contract; awaiting next list of structures. Contract is renewable.
- Bridge Painting Not starting in Albemarle County until mid-summer
- **Bridge Deck Cleaning and Washing –** In process of renewing contract; awaiting next list of structures. Contract is renewable.
- SF 810 Blackwell's Hollow Road (Str. 6131) Superstructure Replacement August 2016 anticipated start
- SF 641 Frey's Mill Road Timber deck Replacement Complete

Road Projects

- Route 784 Doctors Crossing Rural Rustic—Scheduled for July.
- Route 822 Brocks Mill Road Rural Addition—Under construction.
- Interstate 64 Active Traffic Safety Management System installation from mile marker 107 (Crozet exit) to mile marker 94. Construction to be completed by June 2016. System to be functional by August 2016.
- Plant Mix Schedule Work is currently underway. See attached route listing.
- Surface Treatment To begin in July. See attached route listing.
- Latex Modified Route 20 Stony Point Road is complete and ready for pavement markings. Work continues on Route 20 Scottsville Road and should be complete mid-June.
