Dear Chairman Palmer and Members of the Albemarle County Board of Supervisors:

I am writing to seek reappointment as a County representative on the JAUNT Board of Directors. I have served on the Board for four years and was recently elected to serve a third year as JAUNT's President.

During my term on the JAUNT Board there have been significant changes and improvements at JAUNT. While I have been President JAUNT's Executive Director, Donna Shaunesy, retired and I led the effort to select a new leader for the organization. We were fortunate to have an outstanding internal candidate, but the Board made that appointment after considerable deliberation and identifying specific goals and expectations that we had for the new Director and the future of JAUNT. I also initiated a new performance review process for JAUNT's Executive Director. The process focuses on the critical areas of performance and also included the Board's expectations for the upcoming year.

JAUNT, and all transit organizations, have had to deal with significant financial issues in recent years. Specifically, authorization of federal funding was in flux and the Commonwealth made significant changes in transit funding and performance requirements. I have led the Board in advocating for federal transit funds and encouraged staff to bring Congressman Hurt to JAUNT to understand what we do and the importance of federal funding. I worked with JAUNT staff to insure that we maximize state funding, and I have been at Albemarle County Board meetings when JAUNT issues are discussed and also at the Nelson County Board budget meeting this year.

During my term on the JAUNT board I have worked with the staff to develop a strategic plan and to identify opportunities to better serve the residents of Albemarle County. I believe that the new 29 North service is an important initiative for JAUNT; and that we need to work with CAT to determine how both systems can work effectively together to enhance transit service and minimize transit costs.

Professionally I have worked at Washington Metro, Dallas Area Rapid Transit and New Jersey Transit. My role in these organizations included managing operations at bus garages; budget and management analysis, and community and governmental relations. I worked for the American Public Transportation Association (APTA) for 17 years where my portfolio included procurement issues and development of standards for bus and rail procurements. I now have a consulting practice and am currently working on strategic planning and rail safety projects. In addition to my service on the JAUNT board I worked with Meredith Richards to obtain state support for Amtrak service in central Virginia. That service has become one of the most productive rail services in the Amtrak system and hopefully there will be a second train. You have also appointed me to the MPO's Citizens Transportation Advisory Committee.

I know that the Albemarle County Board members attended JAUNT's employee recognition dinner last weekend, an event I have always attended. I would have been there to welcome you but I was in Los Angeles at the APTA Annual Meeting.

I look forward to continuing to enhance JAUNT's service and effectiveness and hope that you will reappoint me as an Albemarle County representative to the JAUNT Board. Thank you for your support.
