RE: ACE LOD2016-00023 - OFFICIAL DETERMINATION OF PARCEL OF RECORD AND DEVELOPMENT RIGHTS - Tax Map 92, Parcel 58

Dear Mr. Kerley and Ms. Kerley:

The County Attorney and I have reviewed the title information for the above-noted property. It is the County Attorney's advisory opinion and my official determination that Tax Map 92, Parcel 58 is one (1) parcel of record with five (5) theoretical development rights. The basis for this determination follows.

Albemarle County records indicate **Tax Map 92, Parcel 58** contains 150.36 acres, is located in the Scottsville Magisterial District and contains one (1) dwelling and several outbuildings. The property is zoned RA Rural Areas.

The most recent deed for **Tax Map 92, Parcel 58**, recorded prior to December 10, 1980, the date of adoption of the Zoning Ordinance, is recorded in Deed Book 465, Page 390, dated October 27, 1969.

On the basis of these deeds Tax Map 92, Parcel 58 is one (1) parcel of record with five (5) theoretical development rights.

The parcels are entitled to the noted development rights if all other applicable regulations can be met. These development rights may only be utilized within the bounds of the original parcel with which they are associated. These development rights are theoretical in nature but do represent the maximum number of lots containing less than twenty one acres allowed to be created by right.
