## **Construction Activities**

#### Route 29 Solutions Project Details

- All Route 29 Solutions projects remain ahead of schedule. The contract for the Hillsdale Extended project is approximately 60 percent complete and expected to be completed by October 30, 2017. All design-build projects are currently four months ahead of schedule and are expected to be opened to traffic by July 2, 2017 and completed before the end of July 2017.
- The Rio Road GSI project was completed on December 2, 2016.
- The **Route 29/250 Ramp** Improvement Project (Best Buy Ramp) construction is complete. Landscaping is complete and wall staining is underway and will be completed in July.
- The **Project Delivery Advisory Panel** held a meeting on June 22<sup>nd</sup>. PDAP meetings are now held monthly.
- The adaptive signal phase I work is complete. VDOT has coordinated with the City and County to abandon
  installation of the adaptive system and instead focus on a performance metrics based system. The City and VDOT
  are developing an agreement where VDOT will take over operations and maintenance on five signals near the
  City/County line to ensure continuity of operations across municipal boundaries. The performance metric based
  system is already in operation along the Route 29 corridor in the County.
- The **Hydraulic/Hillsdale South** study is underway. The Hydraulic Planning Advisory Panel held meetings on June 8<sup>th</sup> and June 22<sup>nd</sup>. The next public meeting is scheduled for August 23<sup>rd</sup>.

## **Bridge Projects**

- 606 Dickerson Road (Str. 60130) Southern Approach Span Replacement State forces construction began on May 8<sup>th</sup> and is scheduled to be completed on July 29<sup>th</sup>, weather dependent. Project Details
- Route 795 Blenheim Road over Hardware River Superstructure Replacement Construction began on Monday, January 23<sup>rd</sup>. Beams installation complete for span A & C. Truss for span C is expected to deliver around May 24<sup>th</sup>. Contract completion is October 30, 2017. Project Details
- Route 250, Substructure Repair and Latex Overlay over Route 29/250 Bypass The contractor has begun
  working. The fixed completion date is September 28, 2017. <u>Project Details</u>
- Interstate, Primary & Secondary Bridge Deck Cleaning contracts Contractors will start work around April and finish in August. Mobile operations throughout the entire District.

### **Road Projects**

- Route 685 Bunker Hill Road Rural Rustic State forces construction is complete and road is ready for surface treatment which is projected to be completed by the end of July, weather dependent.
- Resurfacing Projects Plant Mix, Slurry Seal and Surface Treatment. List View Map View

# **Traffic Engineering**

### **Completed studies:**

  - Signing, pavement marking review; complete. Installations pending
- Route 20/53, No parking signage

- Route 631, Old Lynchburg Road Safety review
- Route 250 at WAHS, Henley MS and Route 240
   Timing Plan. Field review complete.

## **Safety improvements:**

- The signal at Rio Road and Earlysville Road will be rebuilt to improve efficiency and safety. The schedule is to be determined.
- Soil nails were installed on **Route 810** to build up the shoulder for guardrail installation which was completed on April 27<sup>th</sup>. State forces are currently developing a plan for tree removal and trench widening.

# **Maintenance Activities**

VDOT Area Headquarters crews completed the following activities during the past month. For specific route activities, please contact the Charlottesville Residency Office.

- Culverts repaired 5 secondary routes
- Debris removal on 2 primary routes and 9 secondary routes
- Drainage repairs made on 2 primary routes and 6 secondary routes
- Machining on 24 NHS secondary routes
- Patching along 2 primary routes and 17 secondary routes
- Shoulders repaired along 2 primary routes and 4 secondary routes
- Tree removal on 2 secondary routes
- Trimming on 3 primary routes and 12 secondary routes
