

**For much of my professional career, I have been involved with some aspect of economic development. Upon graduation from undergraduate school in Florida, I was employed as the Assistant City Manager for the City of Deland, Florida. Among my other duties, I was responsible for recruiting commercial and light industrial businesses to the 1700-acre business park at the Deland Municipal Airport.**

**Upon returning to Virginia in 1978, I was hired by the City of Charlottesville as the Chief Budget Officer and charged with implementing Zero-Based Budgeting in the City. In 1980, the City created its first full-time Department of Economic Development and, after a national search, I was selected as the Director of the Department. One of my “other duties as related” was serving as the Executive Director of the Charlottesville Industrial Development Authority, the City equivalent of the Albemarle Economic Development Authority. I served in those positions for 14 or 15 years before leaving to begin my own real estate consulting and development company.**

**I believe that thoughtful economic development has never been more important to communities in Virginia and elsewhere as traditional local government revenue sources have become strained and competition for new business has become more acute. I am always excited to see a project with which I have been involved begin to materialize and “come out of the ground” and that project’s positive impact on the community becomes apparent to all.**
