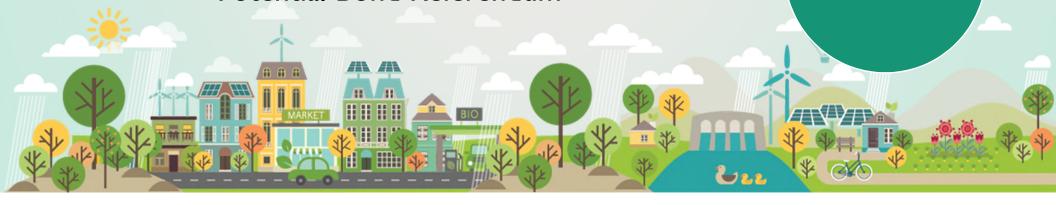

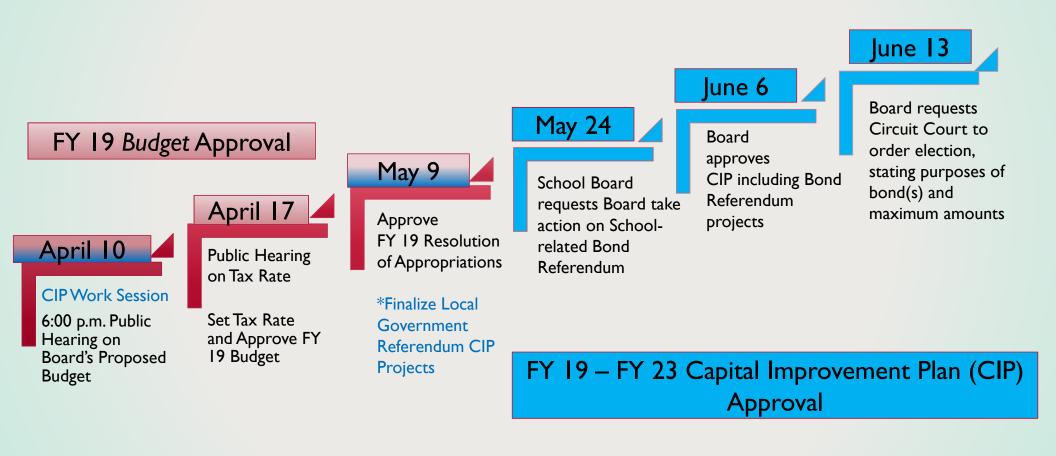

APRIL 10

ADDITIONAL CIP SCENARIO OPTIONS

March 29 Board Guidance:

Begin with Scenario 3 and provide additional options for Board's Consideration

Don't exceed expenditure level associated with Scenario 4

(i.e. do not exceed an estimated 4.3 cents increase on tax rate over 5 year period)

- Police Evidence Processing and Specialty Vehicle Storage (Design is partially funded in FY 19)
- Central Library Renovations
- Public Safety Training Academy

SCENARIO PRINCIPLES/ASSUMPTIONS

TIMING VARIABLES

 The sooner the increase in ongoing resources, the greater the overall capacity

On-Going Resources

 Utilizing shortterm borrowing can delay debt service payments up to 2 years

Short-term Borrowing

 Spending in FY 22 and FY 23 may require additional resources in out years

Out Years

 End-of-year capital contributions can decrease or delay need for additional ongoing resources

> End of Year Contributions

COST VARIABLES

 Interest rates may change over time

Interest Rates

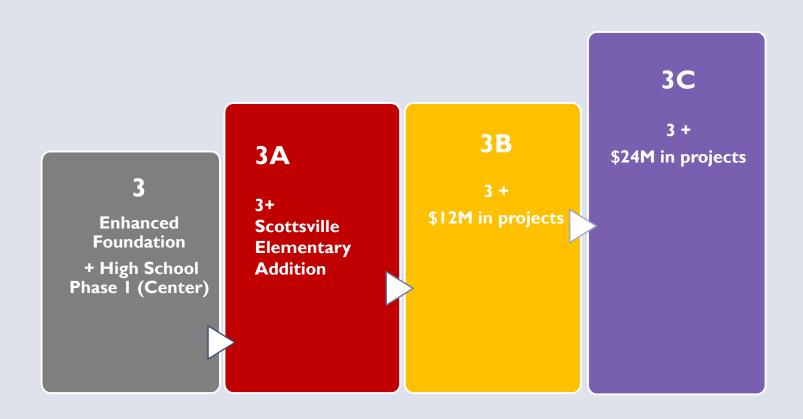
 Project costs are best estimates and can vary over time

Project Costs may vary

 Operating cost impacts require further scrutiny

Operating Costs not fully known

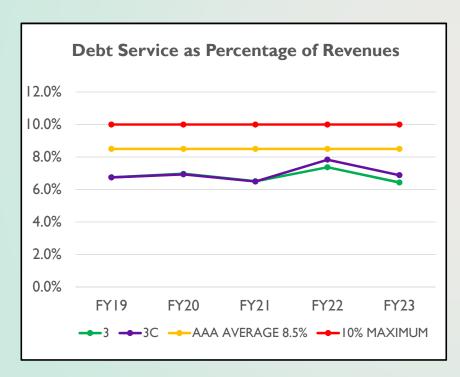

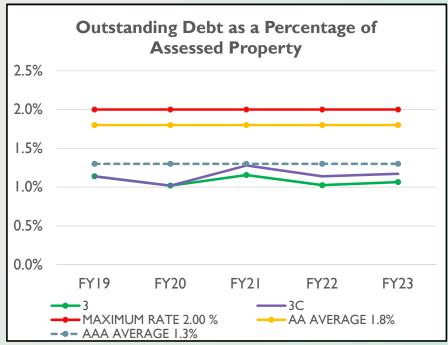

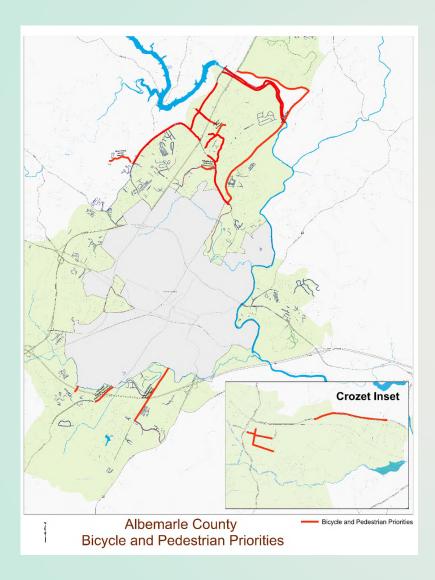

POTENTIAL PROJECTS FOR CONSIDERATION



SCHOOL PROJECTS

- Scottsville Addition and Improvements \$12.1M
 - Current Scope:
 - Addition(s) 20,000 sf
 - 4 additional classrooms + support spaces
 - Full-size gym
 - Site improvements
 - Outdoor learning areas
 - Septic system replacement
 - Improvements to the existing building
 - Modernization & Renovation
 - Convert existing gym into 2 classrooms
- Learning Space Modernization Elementary & Middle
 Schools \$6M per year
- High School Modernization



TRANSPORTATION

- Albemarle Bicycle Pedestrian Construction Program
 - Unfunded Pedestrian-Bike Projects based on Board approved priority list
 - Examples of 9 potential projects that could be advanced
 - \$9.8M estimated total cost, based on unit cost
 - Able to be leveraged with state or federal funds

- Northtown Trail
- Greer/Jouett SRTS
- Old Lynchburg Road Shared Use Path
- Fifth St. Ext Sidewalk and Bike Lane
- Avon Street Ext. Shared Use Oath
- Tabor, High, and Hilltop Sidewalks
- Hillsdale Dr. Sidewalks
- Woodbrook SRTS
- Rt 240 Shared-Use Path



COMMUNITY FACILITIES AND GREEN SPACE

- Walking, Hiking, and Biking Trails
 - North Rivanna Greenway \$300k
 - Hedgerow Trail Park \$2.2M
- Athletic Fields
 - Darden Towe Synthetic Turf and Lighting \$2.8M
 Note: City's funding toward operating/CIP expenditures is 31.46%, potential of \$906,928 offset
- Open Space/Conservation Parks
 - Hedgerow Trail Park \$2M
- Large Community Parks
 - Crozet Community Park Western Park located in Old Trails -\$3.9M
 - River Access/Boat Launch Rivanna Reservoir Boat Launch \$IM
 - Buck Island Creek Park/Boat Launch \$706k

*Includes initial estimates



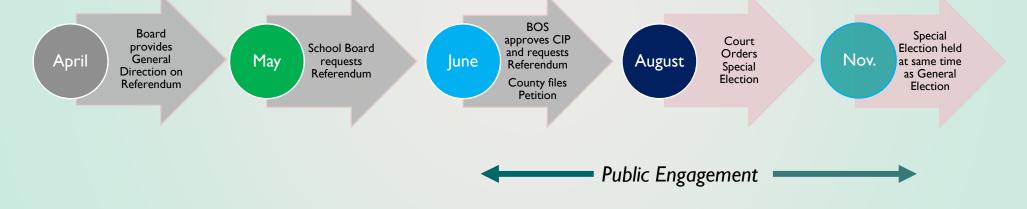
PUBLIC SAFETY

- Fire Rescue Training Facility \$4.1 M
- Components:
 - Burn Building
 - Training Tower
 - Practical Training Area
- Provides:
 - Mandatory initial and ongoing training for career and volunteer fire rescue personnel

POTENTIAL NEXT STEPS

- April 17 Staff provides list of projects
- May 1 Board provides ranking preferences
- May 9 Board determines local government projects to include on Referendum
