Miller School Road (Route 635) Through-truck Restriction Study: Summary

Albemarle County is evaluating whether to request a through-truck restriction on Miller School Road from US 250 (Rockfish Gap Turnpike) to Plank Road (Route 692). The request would be submitted to the Commonwealth Transportation Board (CTB), which is responsible for decisions regarding implementing any truck restrictions.

- According to the Code of Virginia § 46.2-809, "A through-truck is defined as any truck or truck and trailer or semitrailer combination, except a pickup or panel truck, that travels from one point to another and having no origin or destination along the route(s) traveled". The CTB has the authority to ban all through-trucks or set a size limit on through-truck s.
- Miller School Road is classified as a Major Collector making it eligible for a Through-truck Restriction.

Reasonable Alternate Route:

The CTB requires that a reasonable alternate route be developed to the restricted route. Two alternate routes have been provided that can accommodate truck traffic and improve safety for road users in the area (see map on reverse).

- Alternative Route #2 would provide a "reasonable" option for Trucks traveling between US 29 and I-64.
 The distance would increase by 8.4 miles, however, the duration would be slightly reduced and the
 roadway characteristics of I-64 and US 29 are far more compatible with accommodating truck traffic
 than the Current Route.
- Alternative Route #1 might be the best option if the origin or destination is closer to the endpoints of Miller School Road.

Character and Frequency Compatibility:

Safety

- Miller School Road maintains a crash rate of 164.62 crashes per 100 million vehicle-miles of travel north
 of Dick Woods Road and 324.08 million vehicle-miles of travel south of Dick Woods Road. This exceeds
 the Culpeper District Average for 2-lane Rural Roads, which is 147.08.
- Four of the eight curves major curves on Miller School Road do not meet the current VDOT standard for curve radii on this type of roadway.
- Due to the angle of the intersection of Miller School Road & Plank Road, turning paths for trucks with a wheelbase over 30-feet are unable to make the turn without encroaching into opposing lanes.

Traffic Counts

- Two-way Average Daily Traffic = 1,099 vehicles per day (vpd) south of Dick Woods Road; 2,330 vpd north
 of Dick Woods Road
- Total Trucks (Non-Pickup) = 118 vpd south of Dick Woods Road; 148 vpd north of Dick Woods Road
