Hi Andrew,

I live at 480 Stagecoach Rd. and overlook, at an angle, the adjacent police parking lot discussed in the meeting on Thursday. My neighbor at 470 Stagecoach directly overlooks the lot and shares lot lines with the COB on both one side and the rear.

Mrs. Balazs told me that she wrote the county about her concerns, and I gave her your card.

Suffice it to say that as the most immediate neighbors we bear the greatest impact of operations in the lot, and frankly have not found the County to be a particularly good neighbor. We're not informed about noisy operations like the removal of the large tanks even though there obviously had to be advanced planning. This is in spite of the fact that we've complained numerous times in the past about both the noise and not being notified.

Thus we do appreciate the timely information about the tower.

I personally do not like the idea of seeing a tower but understand the need and have no quarrel about it.

The purpose of my writing, however, has to do with whether the County takes seriously the oft heard pledge to be a good neighbor.

Along the left side of the driveway into the lot (along the property line with 470) is a years-old tangle of weeds and vines. Along the rear line the thicket is even more dense and impenetrable, as you could see on Google or the County GIS. It's quite a large sloped area.

The County's landscaping is well maintained on every other property adjacent to the COB, as is easy to verify. No other adjacent area is so neglected.

As hard as we work to keep our yards attractive, people driving by have been looking at this mess for years. In addition, this area is the refuge for every type of critter displaced by all the residential building in this area including coyotes, foxes, groundhogs, skunks, possums and raccoons.

I call my garden fence my fortification but it's hard to joke about since it costs me so much money, produce, extra work and annoyance.

I don't understand how this situation arose or continues, and I suspect that it's outside the scope of your work on the tower, but I hope you can bring up this subject at one of your work sessions. I'm a retired County appraiser and I'm hesitant to complain to the bosses or my Supervisor or make a big deal out of it. But is sure would be nice if the County were a good neighbor.
