More information was needed about Court Square Park!

Numerous complaints about McKee Row prompted the Albemarle County Board of Supervisors to give the 30 ft. wide dirt alley used principally for horse sales and hitching racks to the City of Charlottesville provided that the City should purchase the "old McKee property and erect on it a school for white children." But letters poured in to the City objecting to the construction of a school so near the courthouse and the City acquired title to the street without taking any further action. Almost 4 years later Paul Goodloe McIntire offered to but the McKee property if the City would permit the street to become part of a park in which to locate his proposed sculpture of Stonewall Jackson. This was agreed to be a good plan and McImtire shortly purchased ythe property from four different owners. On January 19, 1919 the McKee property was deeded to the City of Charlottesville. The deed stipulated that the area would never be used as anything but a park and that no statue except that of Jackson should ever occupy it.

I am surprised that the marker to remember those who died in the civil war lacks almost any information about it. It seems to me to be appropriate to keep it to honor so many dead from the Charlottesville community, but needs more explanation as to why it is there, and personally, I think it could also tell the problem of slavery and oppression of African-Americans as the origin of the war. I always thought the marker for a site where slaves were sold should be right on court square because more slaves were sold there than on a stone "block" at number nothing. It wasn't just a commercial matter but a legal and civil one, and that could be presented as a way to understand the profound debacle of so many lives lost (marked by the monument to confederate soldiers). Although the Jackson monument is artistically of value and should be preserved somewhere, it is out of place in this spot. He was not a resident or even visitor to the city and glorifies the Confederate side in the war as heroic (and this obviously offends some people today). Since the McKee neighborhood was the first commericial district of the Charlottesville, and became a predominantly black neighborhood, it should have markers that tell that story on what is now Court Square Park. That absence of the story is glaring to me. I think the history of the surrounding properties outside the square is also worth telling more as well. I am also surprised that there are no monuments to lefferson, Madison and Monroe on Court Square, since they were the most nationallyimportant people to actually visit the square for various purposes. They are mentioned on other markers there and probably there is not interest in erecting monuments to them, but still I find it surprising since it is one of the most historical court houses still standing in America from the founding era of America. I think the modern city hall today has the sculpture of those three men but really that sculpture would be better at court square, not on the downtown Mall. I personally wonder if people will complain about them someday being prominent in the modern city hall, and perhaps if they are to be retained it would be best in a historical context where the city government began - Court Square. I think the square could try to tell local history is a more chronological way if the east side of the square had markers mainly for the city's first century (1762-1858, with Jefferson and founders along with slavery), and then the south side of the the square for its second century (1859-1959 with civil war monument and post civil war history, becoming a city, lynching, etc), and the west side of the square for the most recent history (1960present; civil rights movement, first African-Americans in city government, etc). Walking tours could flow around the square telling that story. I served on the Court Square renovations committee in 2006 that put up the marker on the east side, but would like to see a fuller marker like that on each side. By the way, I also served as co-chairman of Charlottesville's 250th anniversary in 2012 and wrote a diverse history of city that was in the Daily Progress.



Albemarle County Court Square might put up a stocks with good explanation of historical meaning. Currently Albemarle County Court Square does have a historical marker explaining lynching. 


