PROFESSIONAL SUMMARY

Dr. Robert J. Finley has recently served as a consultant on offshore carbon storage site selection (South Korea) and as a reviewer for basic research in carbon capture and storage as a member of a carbon research advisory group at Kyushu University (Japan). Rob served on the US National Coal Council through multiple appointments by the Secretary of Energy from 2015 through April 2020.

Rob served as Director of the Advanced Energy Technology Initiative at the Illinois State Geological Survey (ISGS), University of Illinois, Champaign, Illinois USA, from 2008 to July 2015. He joined the Illinois Survey in 2000 after serving as Associate Director at the Bureau of Economic Geology, The University of Texas at Austin, where he was a researcher and administrator for 24 years.

Dr. Finley's area of specialization is reservoir sedimentology and carbon sequestration, areas in which he has a combined 35 years of experience. His work has ranged from large-scale energy resource assessment, addressing energy resources at national and state scales, to evaluation of specific fields and reservoirs for coal, lignite, oil, and natural gas.

At the ISGS, Rob led a \$100 million project on carbon sequestration in the Illinois Basin, the Midwest Geological Sequestration Consortium, one of the U.S. Department of Energy's Regional Carbon Sequestration Partnerships. In 2009 and 2010, Rob visited China as part of a World Resources Institute-U.S. Department of State sponsored exchange of U.S. and Chinese experts on geological carbon sequestration. Rob served on two task forces of the Interstate Oil and Gas Compact Commission (IOGCC) (2005-09) that developed model legislation and regulations for carbon sequestration. He also served on task forces assessing the nation's natural gas resources, including coalbed methane, sponsored by the National Petroleum Council, in 1992 and 1999. Rob led Illinois' geological site characterization team for the FutureGen 1.0 coal gasification project that was awarded to Mattoon, Illinois, but later cancelled.

Rob received a Ph.D. in geology from the University of South Carolina and holds a current Professional Geoscientist license in the State of Texas (No. 5003).

Overview

Mr. Wuensch is a transportation engineer / planner who understands the importance of designing a transportation system that provides for multimodal mobility options within the context of the community and region. He works with stakeholders and agencies to understand and address the livability of a region or community by finding solutions that balance and optimize vehicular capacity needs, traffic circulation and parking opportunities, travel demand management, transit service strategies, and the needs of pedestrians and bicyclists. He has consulted with communities and agencies in the northeast, mid-Atlantic, and Florida providing transportation planning and engineering services.

Fauquier County On-Call Transportation Engineering

Bill is serving as the County's transportation consultant engineer on an on-call basis. Typical assignments include interfacing with VDOT on land use and transportation issues, conducting small area transportation plans for comp plan updates, assisting the County with transportation planning for their growth areas, conducting special studies, and reviewing Traffic Impact Assessments relative to compatibility with the vision of the specific service districts.

VDOT Urban Development Area Planning – Bill served as the transportation engineer for the analysis of small areas in Montgomery and Fauquier Counties as part of the VDOT administered planning contract. The study effort entails working with the public and local county planning staff to develop build out scenarios for specific growth areas. Recommendations include specifics for roadway network, context sensitive typical sections, intersection improvements, and strategies to mitigate traffic impacts.

Amherst Downtown Traffic Calming and Streetscape Plan

Working through an on-call contract with the Central VA MPO, Bill led a community based planning effort to identify improvements for downtown Amherst. The improvements were largely focused on improving the aesthetics, slowing traffic, and improving the overall pedestrian and bicycling environment.
