## Construction Activities

### Bridge Projects

- **Route 640 Gilbert's Station Road – Bridge Repair** – State forces work to begin on June 28 to repair the current posted three-ton bridge. When complete the bridge will be rated for legal loads. Anticipated completion date is October 8.
- **Route 810 Blackwells Hollow Road – Superstructure replacement** – State forces work to begin late-October, with a duration of 4-6 weeks.
- **Various Bridge Maintenance Repair projects on I64, Route 29 and other routes** – This will be ongoing thru the year. Nighttime or allowable daytime lane closures are expected.

### Road Projects

- **County Safety Improvement and Operations**
  - Incidental Concrete Repairs Completed
    - Rio Road – curb and gutter repair
    - Four Seasons Community – sidewalk, curb and gutter repair in several locations
    - Arden Drive – trees have compromised sidewalk in several locations, tree roots must be removed
    - Ashwood Drive – V-ditch and drop inlet in need of repair
    - Tumbery Circle – trees have compromised sidewalk in several locations, trees/roots must be removed
