overnight animal boarding services. PETITION: Special Use Permit request for a veterinary office and  
animal hospital in accordance with Section 20B.2.E.17 of the Zoning Ordinance on a 3.4-acre parcel.  
No dwelling units proposed. Associated request for a special exception to 5.1.11(b) of the Zoning  
Ordinance for the setback of structures to be closer than 200 feet to a residential lot line. ZONING:  
DCD Downtown Crozet District – commercial, office, service, mixed with residential (up to 36  
units/acre); light industrial uses and single-family detached dwellings by special use permit.  
OVERLAY DISTRICT(S): EC – Entrance Corridor; FH – Flood Hazard Overlay District.  
COMPREHENSIVE PLAN: Downtown – mixed commercial, employment, office uses, residential (36  
units per acre maximum); and Greenspace – public parks, open space, environmental features; in the  
Community of Crozet Master Plan area.
