**BACKGROUND:** In May of 2016 the City of Charlottesville and County of Albemarle adopted MOU's for collaboration regarding transportation, education, environment, and redevelopment/affordable housing (Attachment A). Recognizing the value of regional collaboration, the bodies adopted an additional MOU regarding economic development (Attachment B) in 2017.

The Board of Supervisors continues to demonstrate its commitment to communication and cooperation with regional partners where possible, as well as to promoting an equitable and inclusive community (Attachment C).
